Expanding Apprenticeships & Traineeships is an initiative of the new **VET for School Students Policy** released in 2019 by the Government of South Australia. This initiative includes career opportunities through a training contract arrangement - an apprenticeship or traineeship which allows students in years 10, 11 or 12 to combine school, VET and paid employment. Flexible Industry Pathways will include flexible apprenticeship and traineeship options that allow students to complete their SACE while undertaking a near full-time apprenticeship or traineeship in the workplace during their final year of school.
